LOCATION OVERVIEW



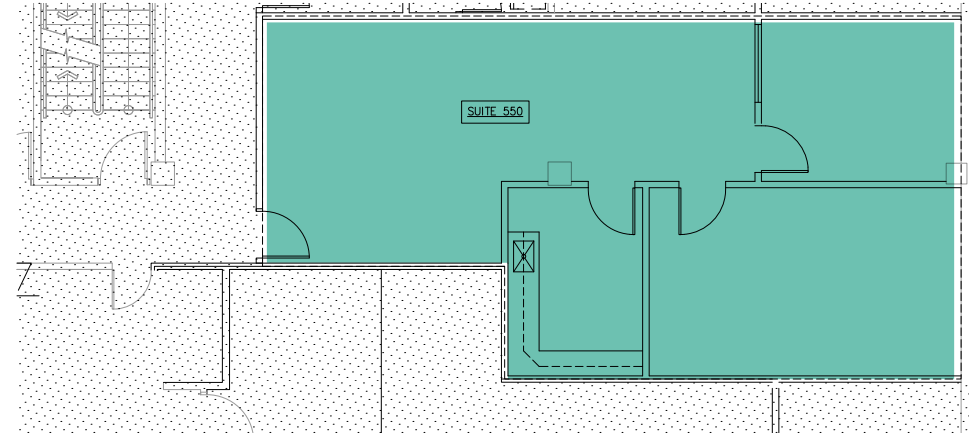
OVERLOOKING RECENTLY REDESIGNED THOMAS SQUARE PARK

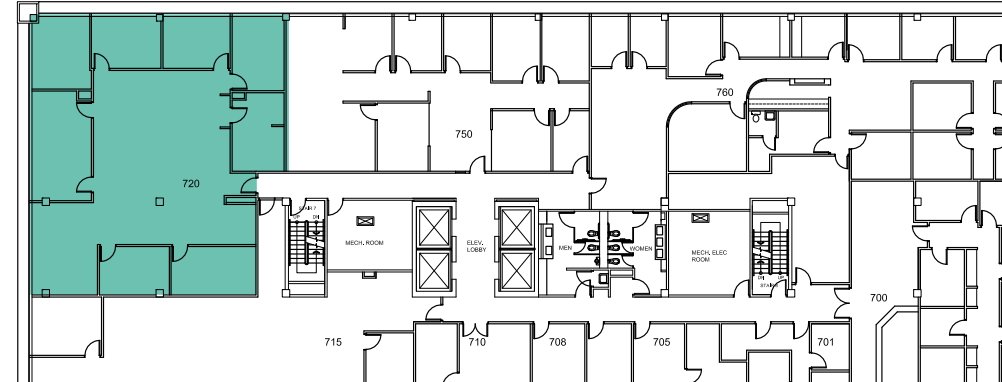

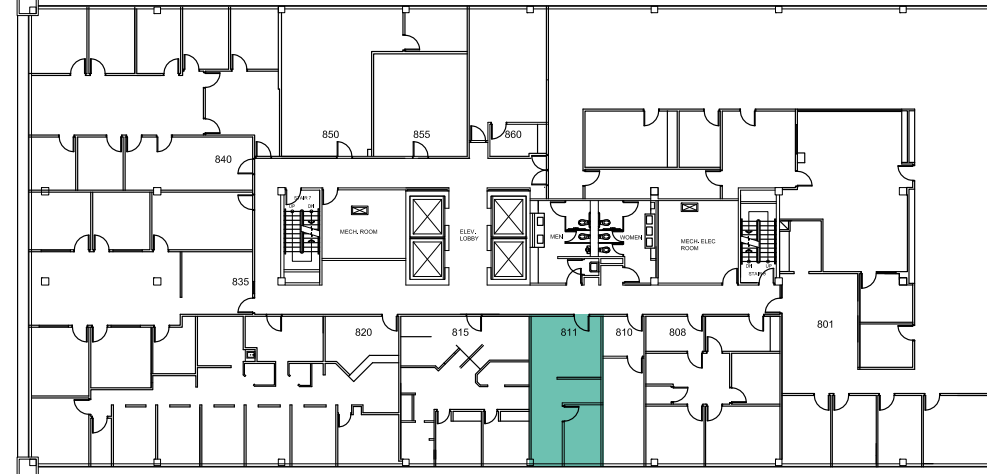
