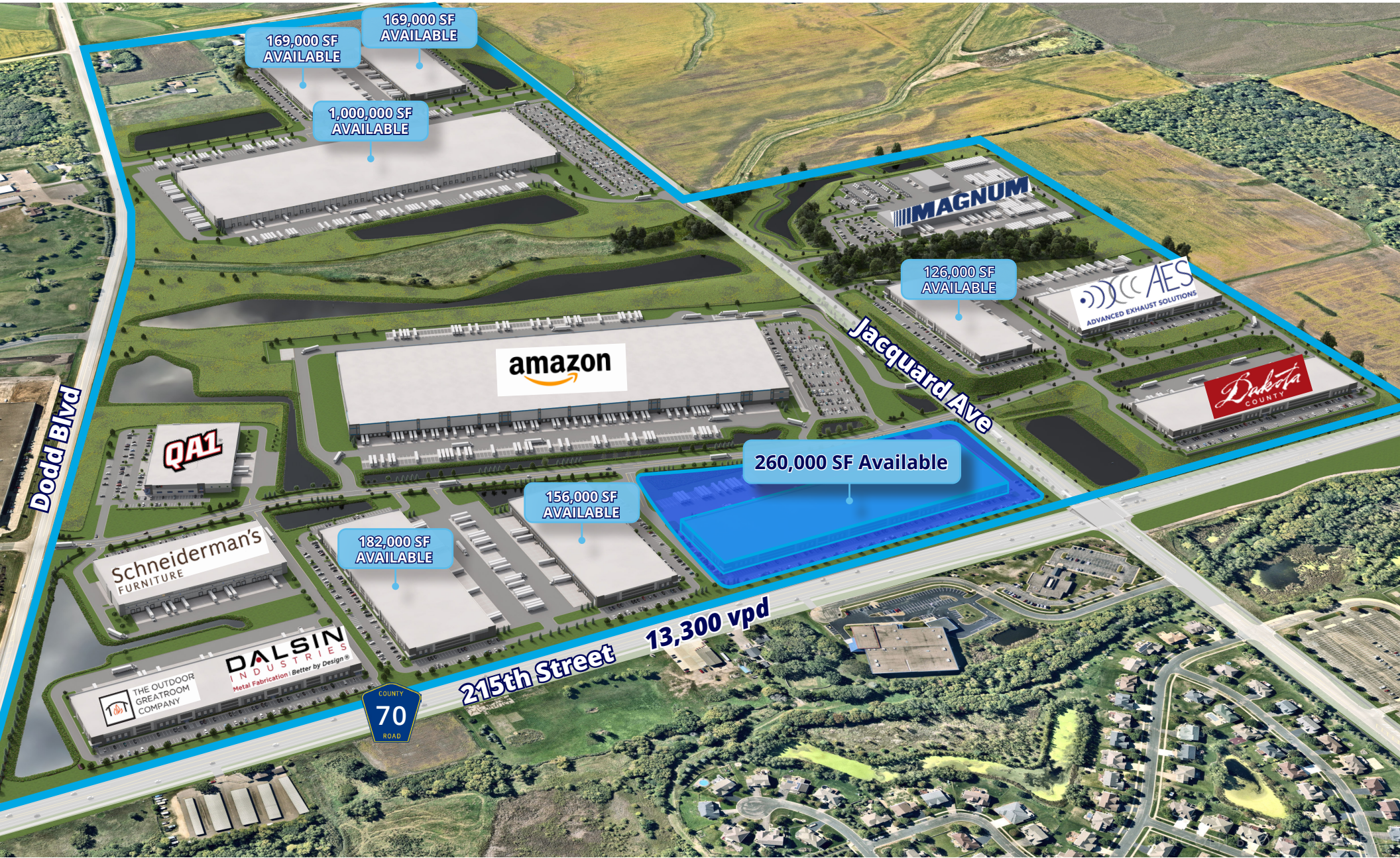
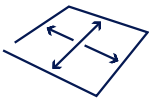
Opportunity

This premier site is well positioned with easy access to Interstate 35, great visibility to CR 70 & Dodd Blvd, and is located in one of the fastest growing communities in Minnesota.

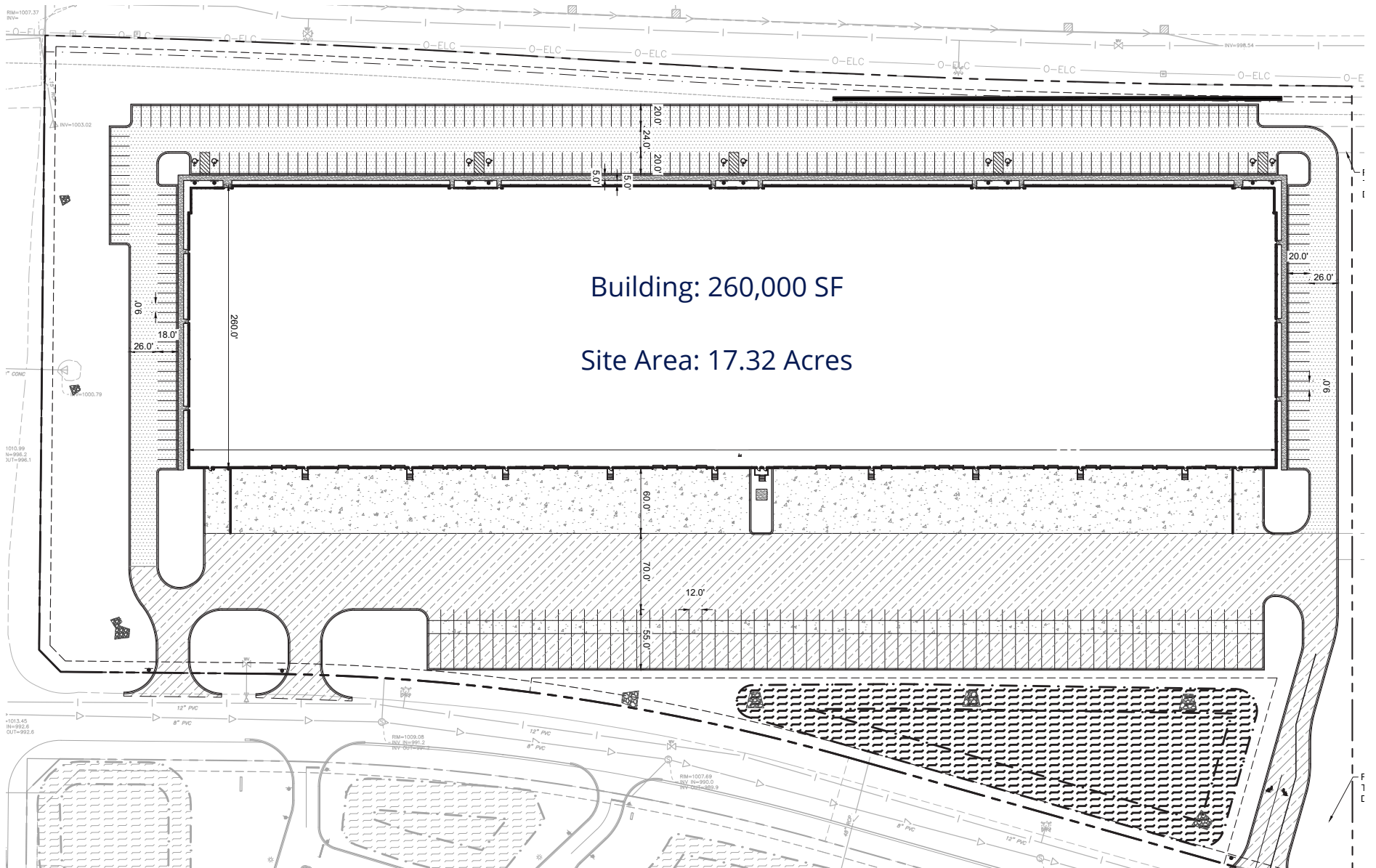

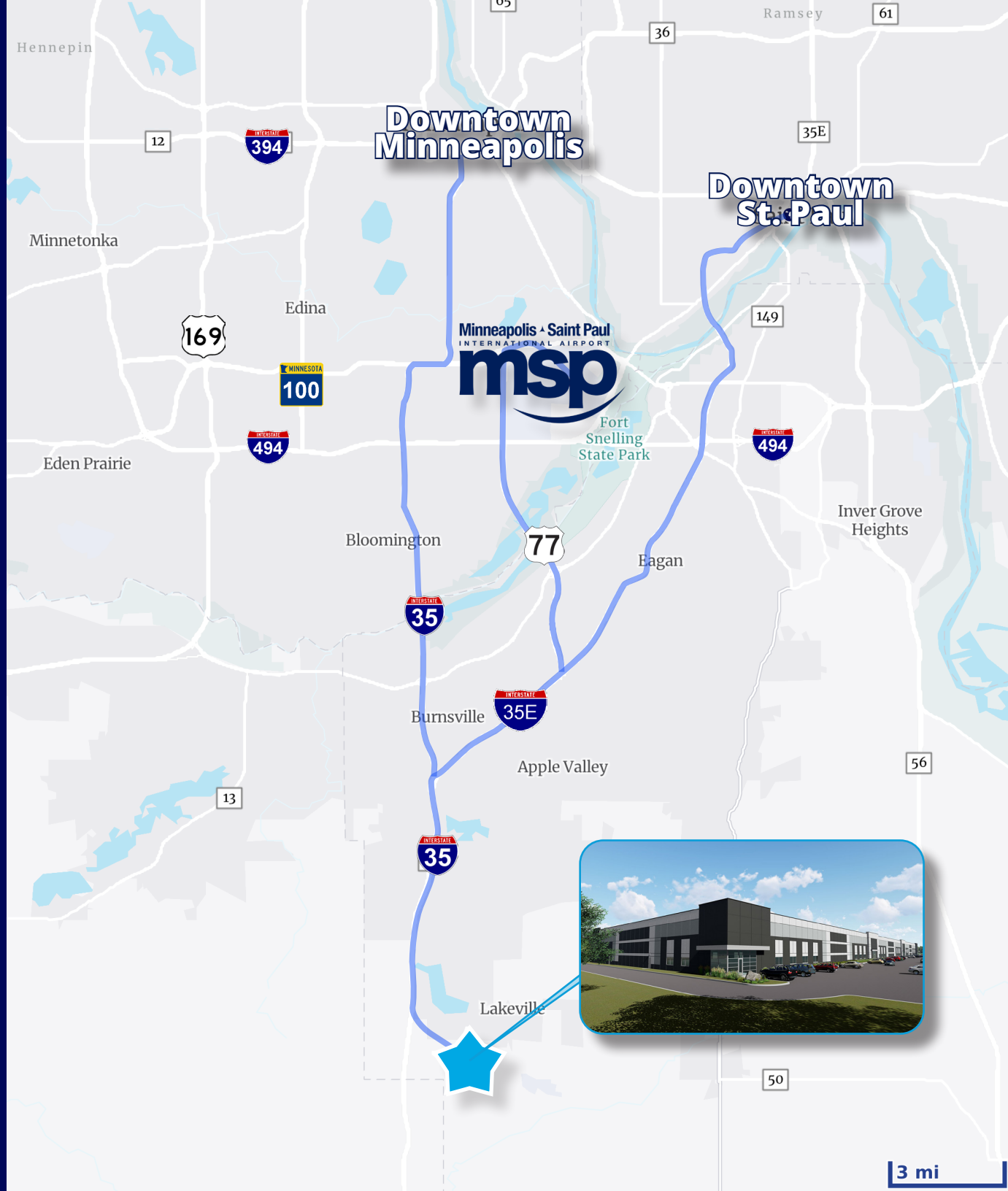

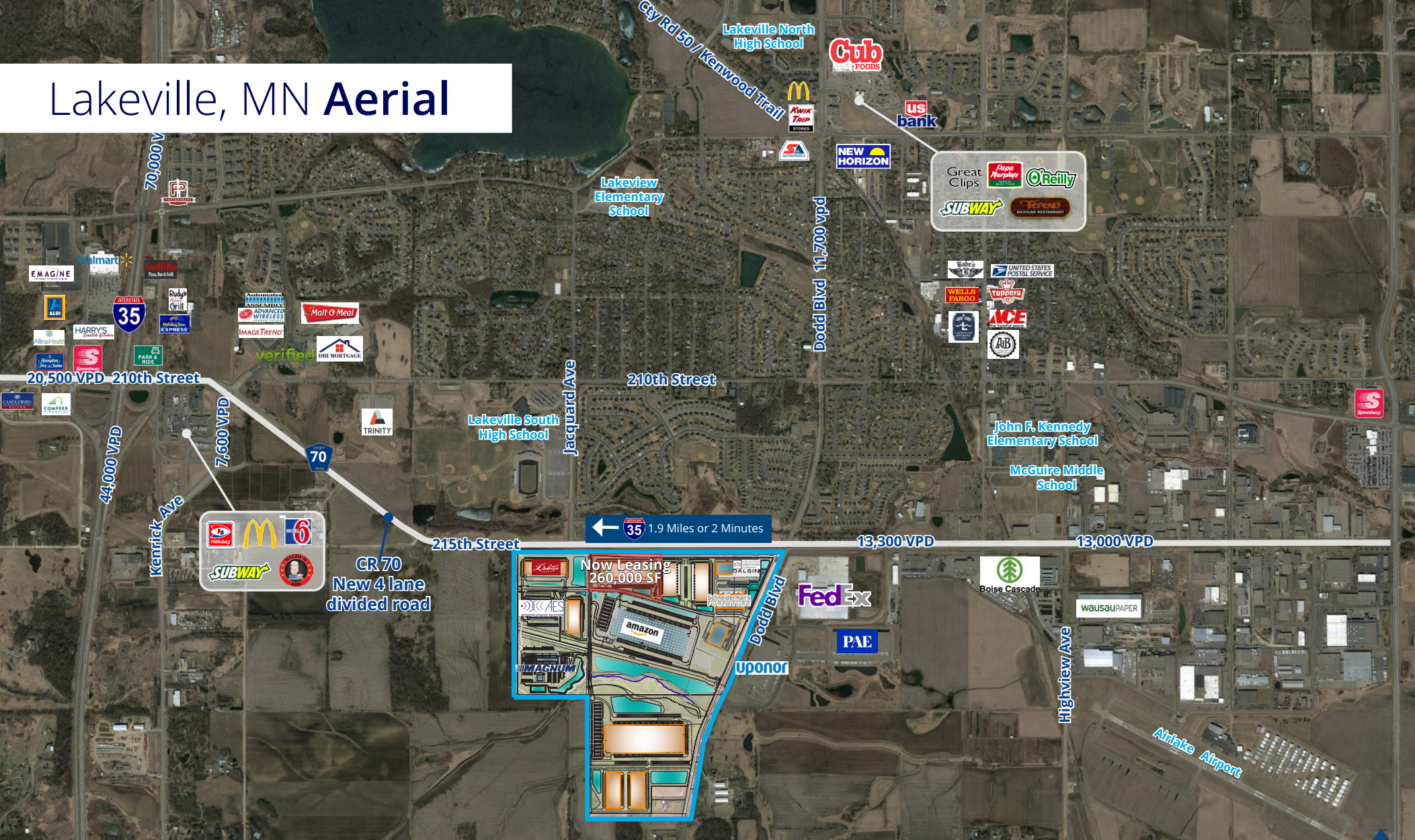
