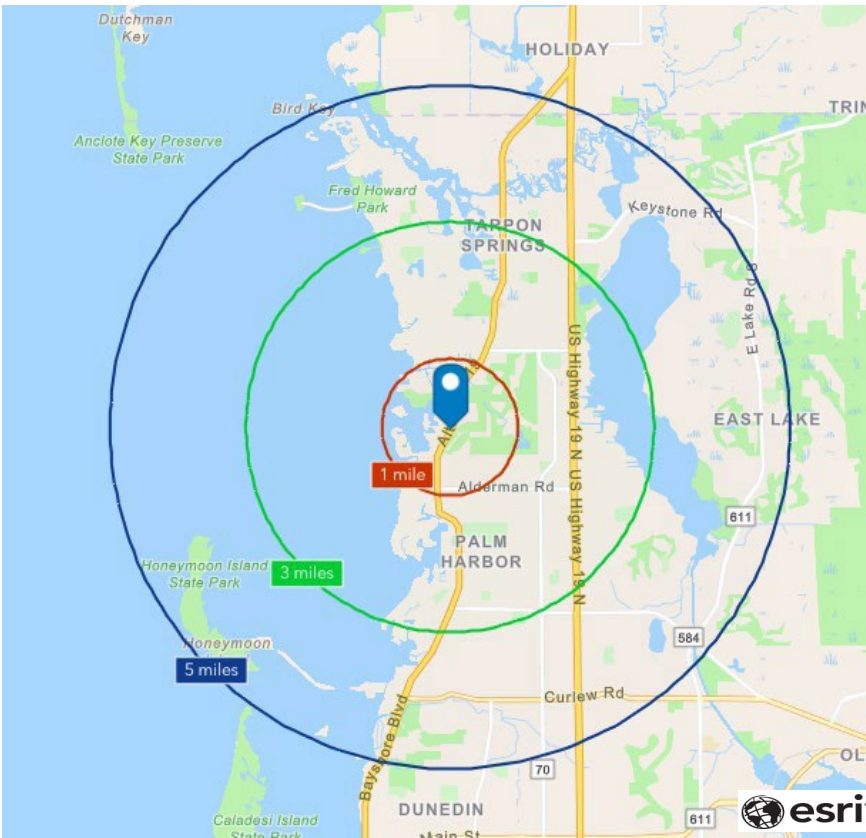
Space Opportunity
