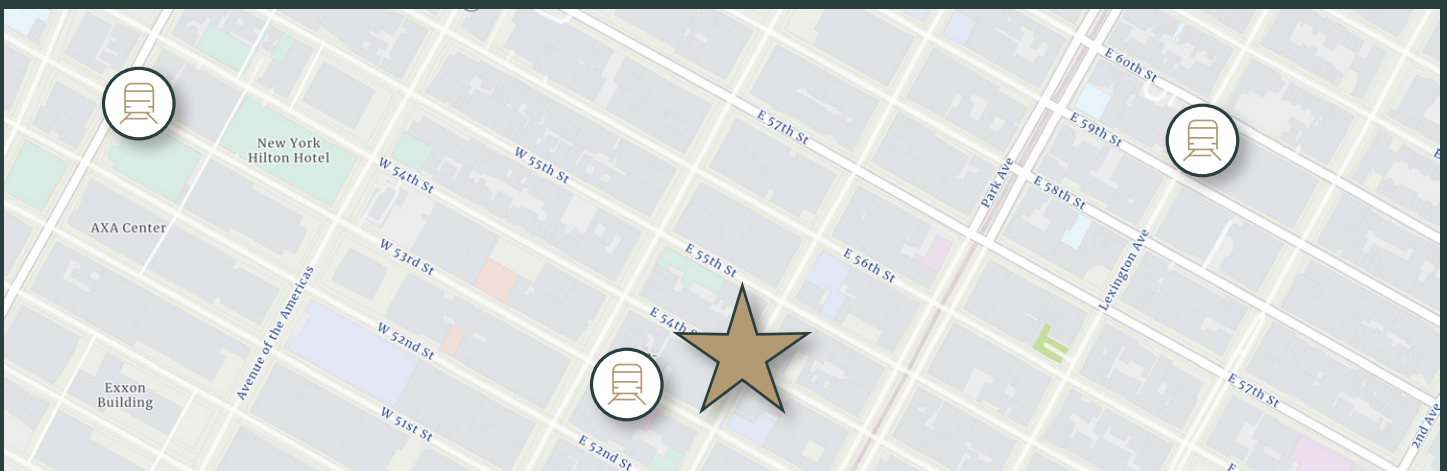

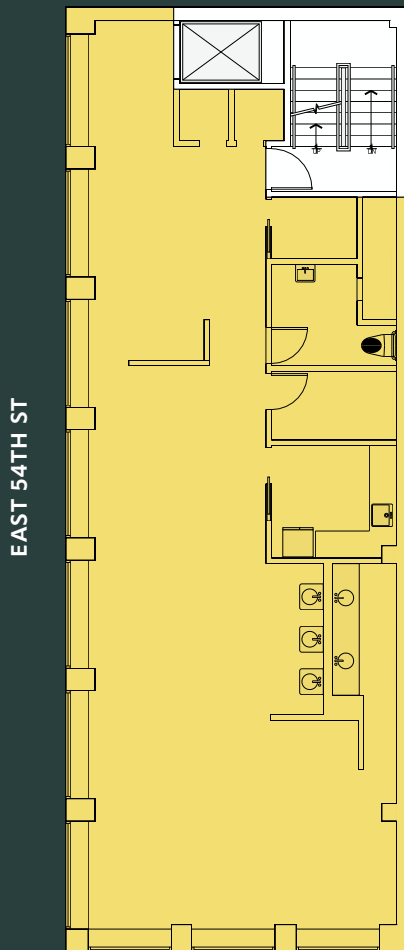

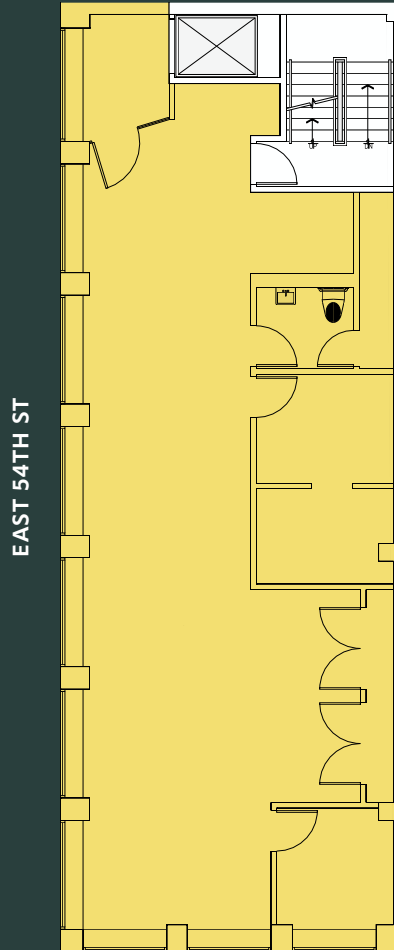
FLOOR PLANS

3RD FLOOR 2,183 SF



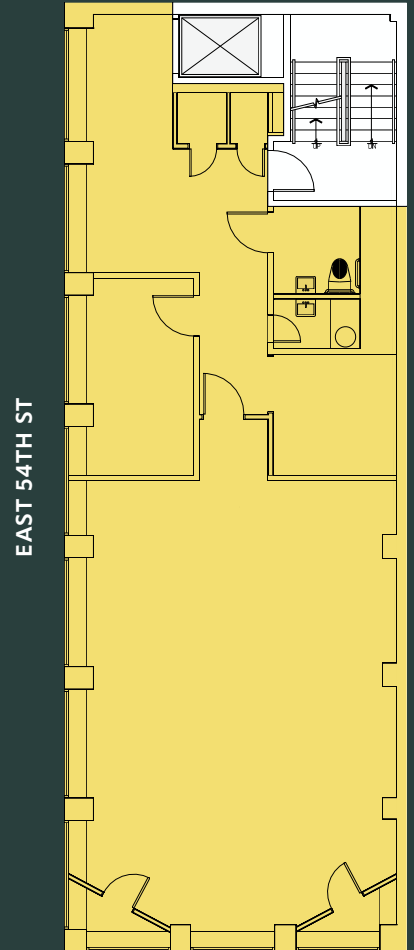
