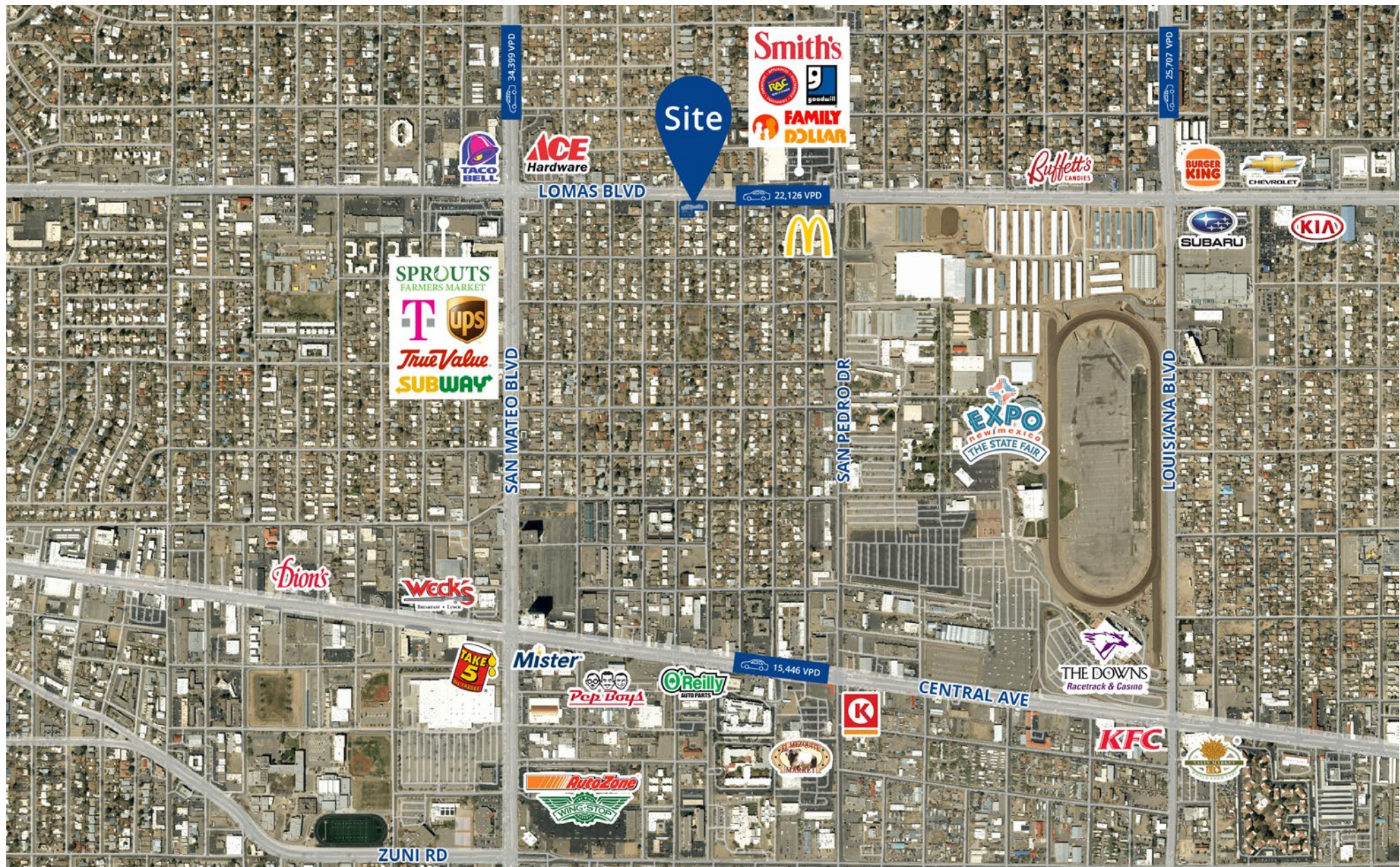

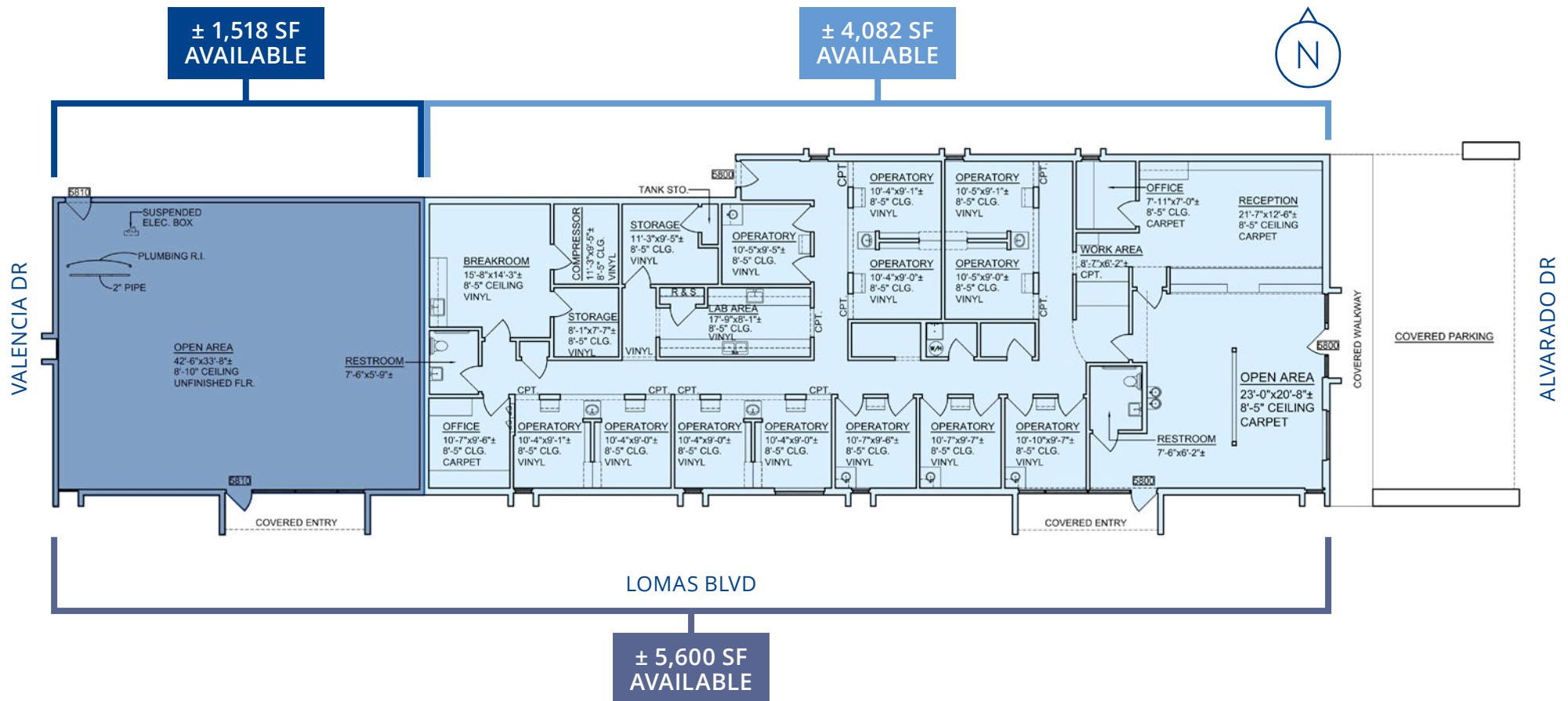
Intersection Aerial

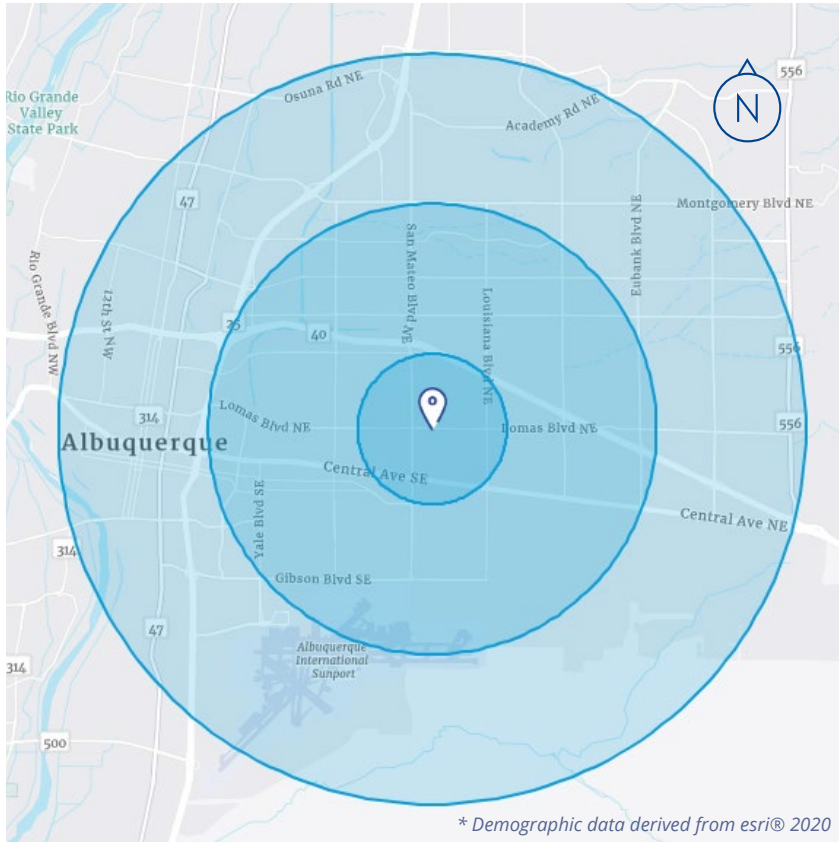
