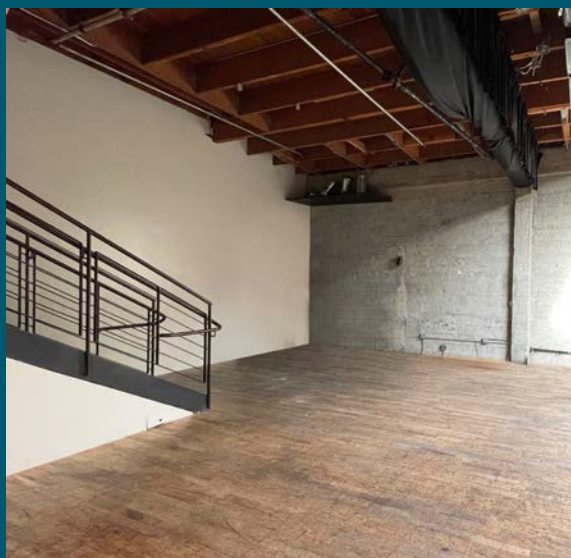

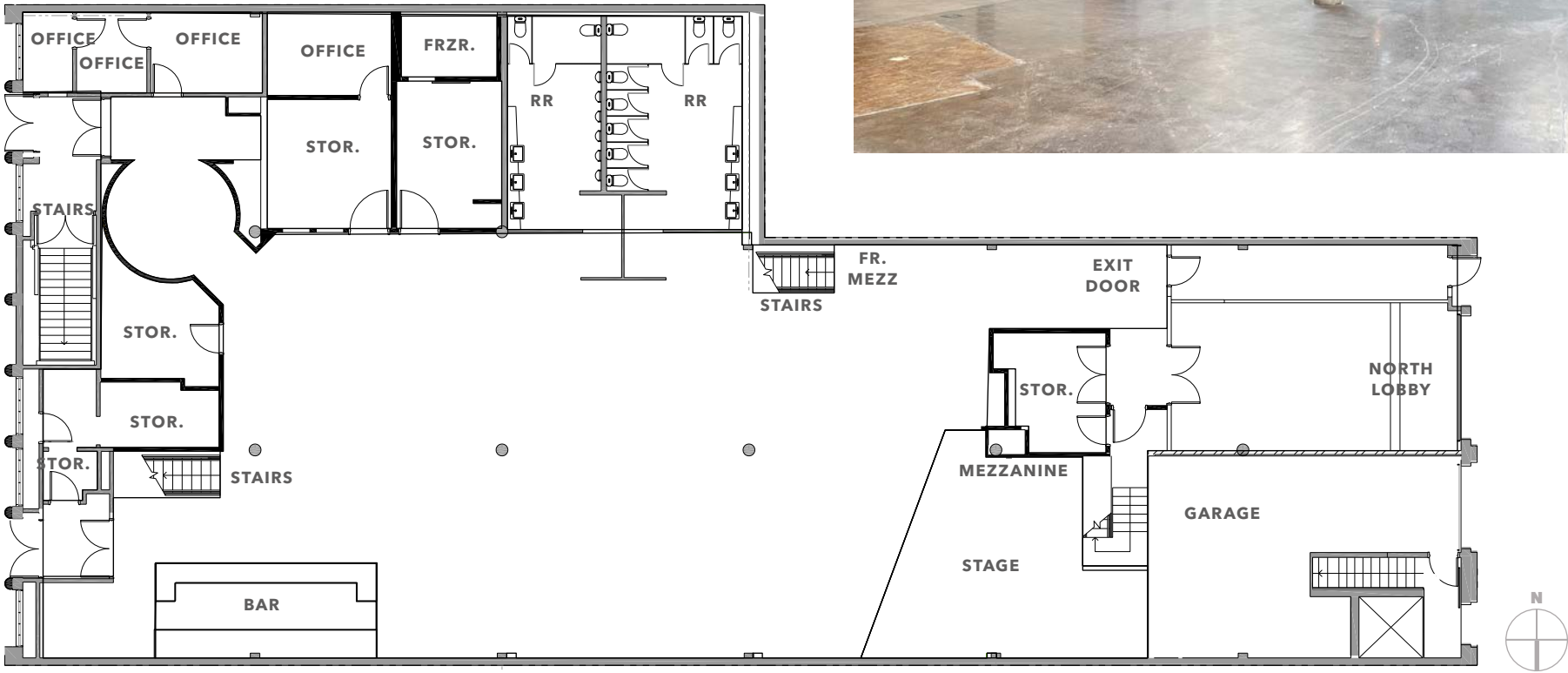
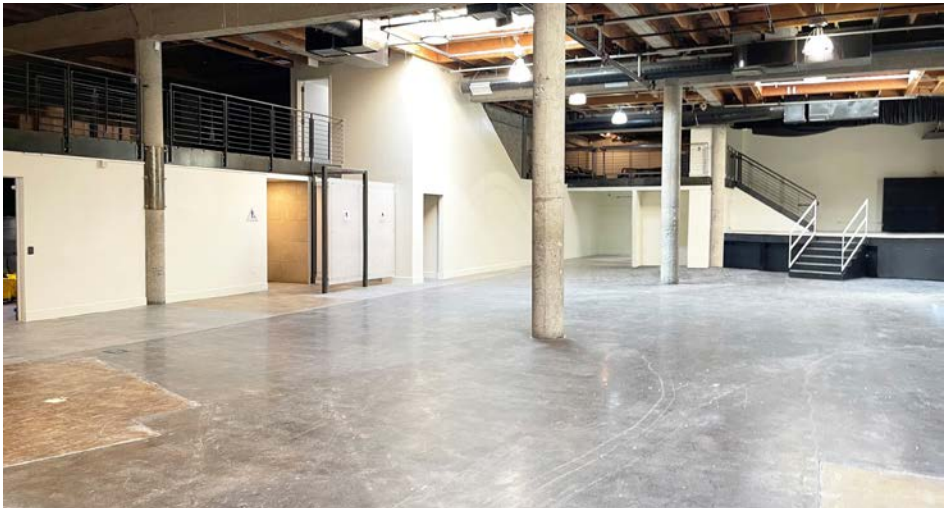

FLOORPLAN NOT TO SCALE

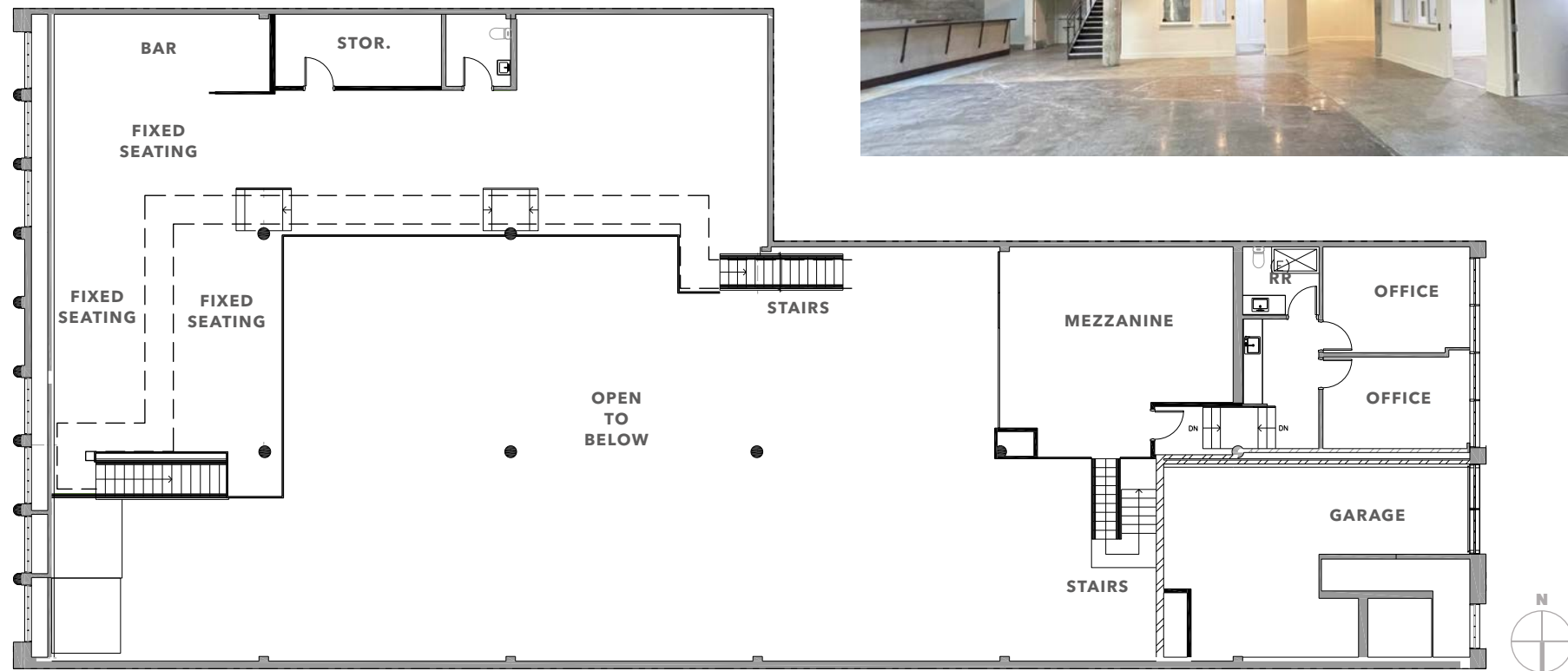

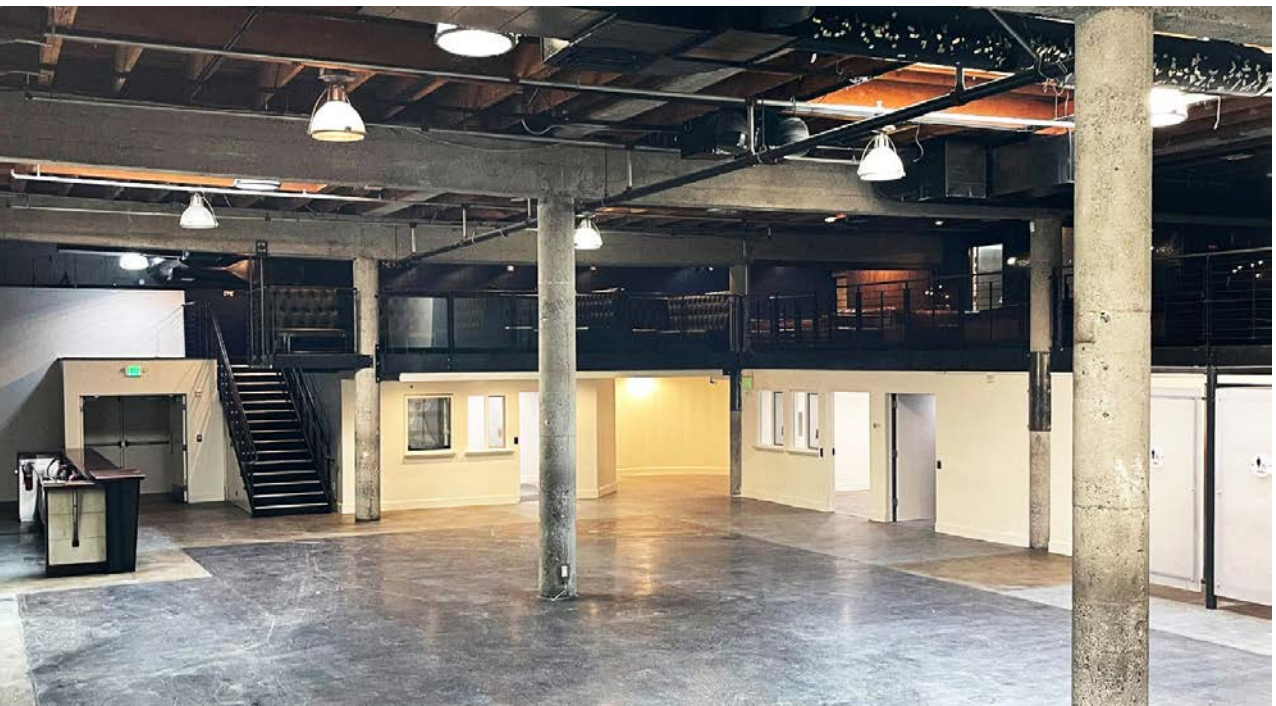


FLOORPLAN NOT TO SCALE

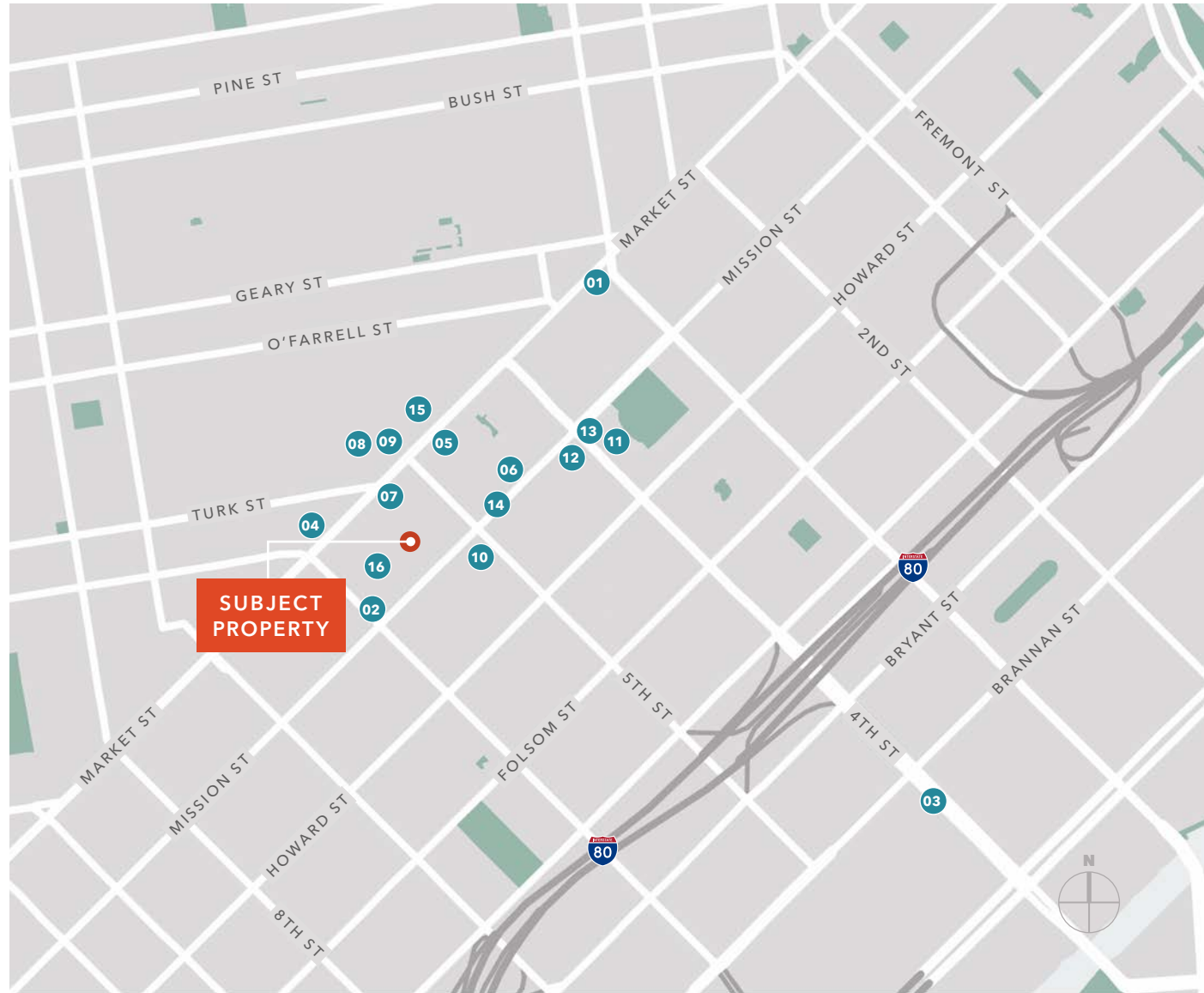
